- These action plans lay out: overview, objectives, alignment to Cooperative Extension Service priority issues and Plan of Work resources, outcomes, ways to engage.
- Plan of Work resources aligns with the Core Program Area Action Plans. However, there may be more within the Core Program Area Action Plans to fully accomplish the objectives of each Core Program Area.
- The goal of this resource is for the 4-H system to use internally or externally to give a menu of options of what is available through the program.

Core Program Area & Plan of Work Evaluations

- Each Core Program Area has an evaluation, one for youth and one for volunteers to be administered after at least six hours of education. Questions align with both the Core Program Areas and the Plan of Work resources. Those that align to the Plan of Work will be indicated by numbers that correspond to KERS reporting.
- Each evaluation resource includes: nine standard evaluation questions that should be utilized for all youth and volunteers. These nine questions align with KERS indicators for Work and Life Skill Development which measure the 4-H essential skills of civic engagement, communication and leadership. These will be utilized to measure impact for Beyond Ready in addition to other reporting expectations for Plan of Work.
- There may be some questions that do not have KERS numbers, these are to assist in telling the 4-H story and results can be utilized in success stories.
- Agents may use evaluations that are found within specific approved curriculum; however, it is recommended that the standard evaluation questions are asked and any applicable questions from the Core Program Area/Plan of Work evaluations are also asked for KERS reporting purposes.
- The Core Program Area and Plan of Work Evaluations are intended as a menu of options for agents to put together quality evaluations to measure impact through behavioral change.

Ways Kentucky 4-H Collects Data - Statewide

The Kentucky 4-H Program depends on the use of approved resources provided from the state level and accurate reporting through the counties to tell the 4-H story. Methods data is collected on the state level:

- 4-H Online *Reported by Counties*
- KERS (Indicators and Success Stories) Reported by Agents
- Program/Event/Experience Evaluations Administered by Specialists
- National 4-H Index Study (Long-Term) System-wide effort, administered by Specialists, promoted by Agents/Counties
