Continuous	Evaluation of the Plan of Work			
(Information due as part of POW updates each year)	As agents are writing the POW, it is critical to consider how each component (programs, activities) will be evaluated. This is an ongoing process that should occur from beginning to end. However, specific tasks should take place at or near the end of each year/POW cycle. The following are a few key things agents (and CEC) should consider when meeting to plan for annual updates: - Highlight impact/results, effectiveness of programs and activities - Determine any adaptations needed for upcoming year Communicate results to stakeholders (clientele, councils, advisory groups)			
Annually by March 1	County Report to the People			
	Each year as the county report to the people is developed, review impact and outcome data for each county priority and connect content in the report to the people to the plan of work.			
Annually by February	Program leaders coordinate the process of providing new or revised state-level resources for reference and use by counties in the annual review and updating of their county plan of work. Priority indicators are updated prior to April 1 <sup>st</sup> each year.			
Annually March – April	Counties review plan of work with advisory councils and CEC, discuss new and emerging issues, and outline updates for the plan of work.			
Annually April - June	The Plan of Work template opens in KERS annually on April 1 <sup>st</sup> . Counties will enter updates by mid-May for AED review. Changes must be finalized and approved by June 30 <sup>th</sup> .
